

# OCTC Committee Meeting 16 September 2021

## Minutes

- **Minutes of Last Meeting (15<sup>th</sup> July,** August meeting cancelled due to covid lockdown)

### Matters Arising:

- **Agility Show Sec Delegation** - Leave until next meeting.

- **New Committee Member**

Teo Georgescu attended the meeting and offered to take up the vacant position on committee. Jean moved that Teo be accepted onto the Management Committee, seconded by Jean. Passed unanimously

- **Agility Equipment Standardisation**

The DNZ Agility Committee grant application to upgrade our second set of Agility gear was declined. Diana will approach Lynne Hayde about alternative grant options. It is expected that we will still ask Simon Monson (Southern Steel Fabrication) to undertake the work.

- **Non-members at Training Rule Change**

Elaine has told Jill that the committee was prepared to look into a rule change proposal, with some modifications. Jill was going to let our Obedience members know. Diana will put together a list of pros and cons, and suggestions as to how this might work, to present to the next meeting. Any proposal and rationale needs to be presented to members no less than three weeks before the AGM.

- **Ribbon Grant**

Quote received. As the grant could not be processed in time, a separate order was put in for September ribbons and the grant will apply to ribbons from March 2022 to September 2022 instead. For the grant application to proceed, the committee needs to pass a resolution to apply for a grant from Bendigo Valley.

*Ailsa moved that Otago Canine Training Club apply to the Bendigo Valley Foundation for \$3634.36 to purchase ribbons for Agility, Obedience, and Rally-O competitions for 2022 . Seconded by MaryRose. Passed unanimously.*

- **PO Box**

Letter provided to NZ Post advising cancellation, form completed, and keys returned. Westpac, Crombie Lockwood, and DNZ have all been advised of the change of address. Address is being changed on various platforms but if anyone spots an old address anywhere, please let Diana know. Dianne will advise Alwyn Isaacs and Anne McLachlan of FPMC.

- **Age of Agility Dogs**

This has been sorted out. Dogs are being accepted from 6 months of age.

- **Secretary Contract**

Needs to be signed. Elaine, Dianne and Diana will be meeting to discuss the Secretary role in the next couple of weeks.

- **Noticeboard**

Elaine has provided options for posting course dates on the noticeboard. Only Canine Companion has been posted so far.

- **Invoicing Foundation Class Attendees**

Diana has drafted an invoice/information sheet that can be given or sent out to new people attending Foundation classes (please see attached). This can be emailed out prior to the course starting, or printed and handed out on the first night. This will hopefully make it more obvious to people what they need to pay and what form to complete, and offers a choice of Temporary or Full membership. Diana is happy to fill in details and email these out, or print them for collection.

There is an ongoing problem with people not paying training fees or membership fees, paying the wrong fee, and not completing forms, and instructors not knowing who has paid and who hasn't. Coordinators must send Diana a list of class participants for each Foundation level course so this can be checked. Ideally class lists for all classes should be sent so payments can be identified. Diana will remind coordinators of this.

- **Level 2 Training and Shows Policy**

Diana has drafted a Level 2 policy for the committee to adopt (see General Business).

## Coordinator Reports:

- **Agility (Leigh Birchall) (Melissa/MaryRose)**

Agility has been going well and we have had a steady stream of new handlers coming through. We have a 'train the trainer' night planned for the 24th of August (*cancelled*). We currently have 3 main trainers taking our classes all year long. Our short term is to get more people comfortable in running classes to give our current trainers a break. Our long term goal is to gain enough confident people to eventually form another class level entirely.

As previously explained we have three classes; Foundation, Beginners and starters/competitors. I would like to see another class level slotted in between beginners and starters/competitors because there is such a big jump between these two classes. There have been some members who have moved up between these classes due to breezing through beginners but then end up struggling in starters/competitors. Realistically, the best case scenario for the future would be splitting starters/competitors into two different classes.

On the 24th August we also have an agility meeting scheduled (*cancelled*) to discuss whether we remain at the Equestrian center instead of transferring between there and Forrester Park. Plans are in motion to move our agility equipment from the equestrian center to Forrester Park on the 7th of September at 7.30pm in preparation for our agility show.

I have had members ask if there is a way to pay for the whole year of classes in one payment. I would like to propose this become an option for next year. Below is a rough idea of what could occur:

Between the 1st of February 2022 and the 8th of November 2022 we can fit in 6 blocks of classes. This would be a total of \$288 (6 x \$48). I suggest we lower the total to \$260 creating a small discount of \$28, which would be total of 3.5 individual classes discounted. This is to encourage more people to consider this option as a payment method instead of paying every 6 weeks for classes.

Along with this payment method we explain to people that there are no refunds if you choose to stop attending classes. If anyone decides to stop attending part way through the year it could result in a small profit for the club as the said member has paid in advance. This payment method does not include the club [*membership?*] fee but would be a simpler option for our long term members and a way to thank our members for their support in attending classes. This example/option of payment would only be doable if they pay this way at the time of the first class.

*The annual fee system has been used in the past and for several reasons, it was stopped. The committee did not wish to reinstate it at this stage. Diana will let Leigh know.*

Agility classes re-start 14<sup>th</sup> September.

Thank you for excusing me over the past 3 months and I apologize for not having an agenda written for each month I was away.

Elaine raised the issue of the floodlights needing an electrical check, but there is some question as to whether it is OCTC or FPMC who are responsible for them. OCTC arranged a grant and installed them, but as they are part of the FP building, they may actually be the property of DNZ or FPMC. Dianne will search through her records to see if there is any information on this – if not, she will let Diana and Elaine know so they can try and track down further details.

- **Canine Companion (Lynn van Beers) (Lynn/Jean)**

The July Canine Companion courses were put on hold due to the lockdown with three weeks still to run. This has meant that all courses for the rest of the year have had to be rescheduled/reshuffled. The current classes re-start 15<sup>th</sup> September and finish 29<sup>th</sup> September. The final two courses start 6<sup>th</sup> October and 17<sup>th</sup> November. This means a finish for the year on 22<sup>nd</sup> December, which is very late but better than cancelling the last course altogether.

- **Obedience (Diana O'Kane) (Dianne/Melissa)**

*From Jill:* The Ribbon Trial we ran on Sunday the 15 August had 14 entries from 12 people, not too bad considering our numbers are so low. A number of people from Taieri came which is good and we appreciate their support. Didn't cover our costs as entries came to \$70 and \$9 for gold coin donations for training ring. Vouchers for the 3 judges plus cards came to \$67, and \$30 expenses for one of the 3 judges, no expenses charged by the other two which was very kind of them. Most of the ribbons were donated back to us, so should have almost a complete set for the next RT we run. So a bit of a loss by the time the FP hire is paid and the ribbons paid for but a successful day was had by all. Thanks to our three judges for giving up their Sunday to judge this with an extra thanks to Dawn McCracken for driving up from Invercargill to judge and compete. And of course to the competitors/stewards etc who helped on the day, very much appreciated.

Jill has resigned as Obedience show manager/organiser and will be taking a break from club for the foreseeable future. At this stage, no one has offered to step in and organise Obedience shows. If there is no one able to take over, the committee will need to consider how to run OCTC Obedience shows in the future. There are judges contracted for March, but with the schedule for that show due at the end of next month, this show needs to be sorted fairly soon.

*The committee agreed to purchase a thankyou gift and card for Jill for her years of service to Obedience. Dianne will do this and deliver it to Jill.*

*From Diana:* The first Competitive Obedience six week course officially finished on 10<sup>th</sup> August, three people having taken part over that time. After discussion with Lynn (CC coordinator), this class has now moved to Wednesday night, as Tuesdays really didn't work.

A new course was set to start on 22<sup>nd</sup> September, to coincide with the CC courses, but this is now likely to be 6<sup>th</sup> October. Running classes at Level 2 is not easy and hopefully there will be less restriction by then. Eight people so far have indicated an interest in joining the class.

The decision has been made that handlers now need to have completed CC1 and been "passed" by the CC coordinator before being able to join the class. As getting into a CC class is problematic, there will also be assessment available for those who seem more advanced to see if they are at a suitable level, but this is not ideal. Most CC1 people master the required skills by the end of their CC course, so this is not unrealistic.

We had one Senior handler training alongside the CO course and she really appreciated having the distraction to work with. Space can be made for this to continue with one or two people, but if several senior handlers want to train, they will need a different timeslot or on a different day.

- **Rally-O (Elaine Limburg) (Elaine/Jean)**

New course started on Monday 16th August. 3 in Novice, 7 in Seniors, 4 in Rally 1, 5 in Advanced. Obviously, this got interrupted. 13th September was a mock competition immediately before our rally event. 20<sup>th</sup> September is a break week but I am organising Jo Miller to do some extra training for our members. 27th September was scheduled as a meeting to discuss the Otago Rally event draft rules but this has been postponed. The next course will start 18th October and run for 5 weeks and then another mock competition immediately before our Otago Rally event in November.

Otherwise rally seems to be chugging along. I have altered the hall setup to accommodate the larger numbers of Seniors. There is a competition ring set up for the Seniors so people can practice in this environment and then the Advanced class uses it. There is another segment set up alongside the Novice area. People seem very happy with this arrangement.

Elaine asked if participants in the 13<sup>th</sup> September mock competition night should pay the hall hire, as this was not covered training fees. As half of them were instructors, it was agreed that there would be no charge on this occasion, however in future some payment should be required to cover the cost of nights that were extra to the normal pre-paid block courses.

With regard to the workshop on the 20<sup>th</sup> with Jo Miller, OCTC is being charged \$120 for hall hire for the day/evening. It was agreed that handlers would pay \$30 per dog (effectively per half hour session), with \$20 going to Jo and \$10 towards hall hire. The money is to be paid to OCTC who will then pass the required amount on to Jo.

- **Treibball (Carina Hyink-Gough) (Ailsa/Lynn)**

Tournament on 23<sup>rd</sup> July was successful. Thank you, Diana, for judging. I would like to discuss, before the next tournament, about adding a foundation class to tournaments of one ball at 6m. I think this would really benefit and encourage a lot of our beginners by having a step in between. The next tournament is scheduled for the 1st October.

- **Flygility (Elaine Limburg) (Elaine/MaryRose)**

A training session was held on Saturday 14th August with 2 newbies and 2 seniors. If everyone turns up we have 6 people. Seniors we would have 4 but some dogs are broken so often only 2. Saturday 28th August session cancelled, next sessions 11 September and 25th September. Then we will look at Thursday nights other than committee meeting nights.

- **Forrester Park (Dianne Sprott) - need to start planning roster for Benefit show catering on 9/10 October.**

## Show Secretary Report (Diana O’Kane)

### • Agility/Obedience September shows (11<sup>th</sup>/12<sup>th</sup>)

These ended up running under Level 2 conditions. Mask use presented some issues, but otherwise there did not appear to be any problems covid-wise other than general inconvenience. Agility and Obedience combined was under 100 people so we didn’t need to split the codes, other than keep those inside to under 50.

DCC bookings staff sent an email to Anne McLachlan with three and a half hours notice the day before the Agility show, saying park booking would be cancelled if confirmation of booking and an H&S document was not received by 4pm that day. It was not actually possible to contact the staff member involved, either by phone or email. Anne managed to sort it out eventually but I suggest a complaint be laid as it was just lucky Anne even saw the email in time. It is not clear whether or not we would have been kicked off the park, despite having a permit. Diana will contact Anne to discuss OCTC making a complaint about the lack of notice.

The Agility show was called off with some classes still to run on the Sunday, due to dangerous winds. Melissa has contacted the AC about what we should do about refunds, results etc. Melissa has received a reply from Chris Richardson (chairperson of DNZAC). Results for all classes on Sunday do not count, as a full set of classes were not run due to the cancellation. We have been advised to refund entry fees for the classes that didn’t run (Seniors, Jumpers C, and Jumpers B), and we don’t have to pay levies on those classes. We have also been advised to give out the prizes for the classes that did run. The committee felt that we should appeal to the AC and to DNZ about the results for the classes that did run, as this seems very unfair. Diana will draft an email in consultation with Melissa.

There was no sponsorship for prizes for Obedience. This really needs to be better coordinated in future. Diana will check with Helena and Donna that they haven’t made any arrangements for 2022. If there is nothing organised already, MaryRose will approach Blackhawk. MaryRose is prepared to coordinate sponsorship efforts but not to be responsible for finding it.

Lyn Clearwater provided show secretary services for the Obedience show and, along with Ian, was a huge help to Jill. The club should send them an official thank you and perhaps a gift? Diana will send an official thank you on behalf of the committee. Lyn’s show secretary expenses were \$50

*Ailsa moved that Lyn be paid \$50 for acting as show secretary, seconded by Jean, passed unanimously.*

### *September Agility Show Report from Belinda:*

The show started a little late on Saturday, but we made up time during the day with the help of other agility members. The ground conditions were very trying, with muddy and sloppy areas throughout the rings. Mask compliance was impressive with most people keeping them on when social distancing was difficult. Course walks were good with 99.9% of people using masks. Sadly, Sunday saw the predicted high wind forecast come to fruition, blowing buckets, scribe sheets, chairs and every other show related materials flying. One gust alone dropped an entire course which was when I made the call to cancel the rest of the day, due to safety (having consulted with all judges and Karen Grant as an AC committee member). The pegged gazebo had just prior, been pulled out of the ground by the wind, and saw it travel 6 or so meters through the air, hitting one person and seeing another fall over it in an attempt to grab it. I have lodged a health and safety report through the agility website regards the gazebo incident. Melissa is in contact with the AC regards how to handle refunds/prizes for Sunday.

The DNZAC have asked competitors via Facebook to send them any reports of injuries incurred at Forrester Park as a result of the surface conditions. Diana will contact Karen Grant (AC Secretary) asking for details of any incidents so OCTC can take them to Dunedin City Council, who claim not to have received any complaints.

- **September Rally-O Show (18<sup>th</sup>/19<sup>th</sup>)**

This will be running under Level 2 conditions. We are creeping up towards the 50 person limit and need to keep this a non-public event, so will not be letting anyone except competitors and officials into the hall. Anyone wanting to bring an extra person needs to apply for an exemption and have a good reason.

The Zone 5 Team Trials that were to take place on the park outside the same weekend have been cancelled.

Arend van den Bos (judge) has already booked B&B accommodation so billet not required.

## General Business

- Teo Georgescu – Floofy Photography**

Teo has been taking photos of dogs and handlers at our shows and wants to sell them. At the moment her photos are being downloaded and shared without payment or credit. It was decided that OCTC would be able to use photos for the website, flyers etc, with a link to Teo's own site where more photos can be viewed and purchased, and Teo could promote them via the various OCTC platforms.

- Purchase of Agility Equipment**

Donna and Elaine have donated a blind jump and spread jump to the club. OCTC has paid for these and been reimbursed.

- Uncontrolled Dogs at Training**

There have been a few complaints to Elaine recently re out of control dogs. Our club policy states "Dogs must be kept under control at all times" which includes when dogs are off lead eg for agility. If this cannot be achieved dogs must be kept on lead. It is appreciated that dogs will occasionally run off to another dog but this is not ideal and instructors need to address this. Having an agility dog on lead while training is also not ideal but they can't be allowed to interfere with other dogs in the training area. Over the years, club dogs have suffered physical and emotional stress from such interference and our policy is about keeping all club dogs and handlers safe.

Dogs barking during class is also a problem. Some dogs bark while working, but they should not be barking the rest of the time. This makes it hard for people to hear what their instructor is saying, and it needs to be addressed. Dogs should not be allowed to just stand barking at their handlers.

Diana will include this in an email to coordinators.

- Catering for Benefit Show 9/10 October 2021**

Need to start organising roster. A decision will be made around 26<sup>th</sup> September as to whether this show will run – will be postponed to next year if we are still at Level 2.

- OCTC End of Year Function (Elaine)**

There is some concern about each discipline having their own end of year function and dividing up the club. Fine for them to do this but we should have a club-wide function as well? Consensus was no as it was too hard to find something that suited the majority of members. Perhaps something less formal could be organised instead.

- 2021 Annual General Meeting**

Set for Monday 29<sup>th</sup> November at Forrester Park. Diana will remind coordinators to collect points and order ribbons.

## • **Level 2 Training and Shows**

There have been several queries about mask use and physical distancing at shows and training classes, and a formal policy is needed. This is likely to be required in the future for booking the hall and grounds, and for other compliance measures. It is also likely that masks and physical distancing will remain at Level 1, so we need a long-term policy.

Most comments have come from people who feel the wearing of masks should be mandatory unless a person is in the ring or actively training. There has also been an assumption that physical distancing will be required.

There are, in fact, very few places where wearing a mask in public is mandatory. These consist of public transport, most customer-facing businesses, and indoor spaces open to the general public. If we exclude members of the public and limit attendance to a contained group of known people, there is no legal requirement for people to wear a mask at our shows or our training sessions. It is, however, strongly encouraged. Physical distancing is a bit of a grey area, but in general people are expected to stay two metres away from people they don't know, or one metre from people they do know unless they are close friends or family.

Requiring masks at training and shows is problematic. As they are not required by law, we have no justification for making them mandatory, for enforcing their use, or for excluding people who are unwilling or unable to wear one. Any benefit from requiring masks is completely lost by allowing people to remove them while competing or training – an unmasked person will spread infected air around the ring or training space which is then inhaled by every unmasked person following them, and no amount of physical distancing or mask use at other times is going to prevent this from happening.

With this in mind, my suggestion is that

- all public and non-participants are excluded from shows and training until the situation changes. Exemptions may be applied for if there is a genuine need for someone to be there.
- Indoor training is limited to 50 people per night, and outdoor training is limited to 100 people per night, even if people are attending at different times. The same limits apply to shows but over the entire weekend. These numbers will change if regulated limits are changed.
- We are legally required to keep a record and contact details of every person present at every training session and show. We must hold these records for two months.
- Mask use is strongly recommended but not compulsory. Judges or show managers may ask that masks be worn for course walks and group stays, however no one can be turned away or disqualified for not wearing a mask.
- We advise physical distancing of at least one metre at shows and training, but this is up to attendees. We know everyone present, but we don't know the relationships between them, so can't enforce this.
- We require masks to be worn in public areas such as the carpark, toilet block, and exercise areas when there are members of the public around, and ask that a two metre distance be maintained from the public in these areas.
- We limit access to spaces such as the kitchen, secretary office, garage, and judges' room to those who need to be in there. This is to avoid over-crowding, but discretion and common sense should apply.
- Everyone attending is asked to sanitise their hands when entering the hall or park, before handling any equipment, before prizegivings, and any time they have come into contact with a high use surface, such as door handles or gate latches.
- A QR code AND written attendance sheet must be available for attendees at all training and shows, in addition to our own record keeping. This is a legal requirement.
- Unused training fees, show entries, and membership fees will be refunded upon application to anyone who is unable to attend training or shows due to flu, cold, or covid symptoms, an order to isolate, or general anxiety around covid.

The committee agreed to adopt the above policy
